Keith Edgerton called the meeting to order at 3:45 p.m. in room B57 in the College of Technology.

The minutes of October 27 were accepted as presented.

I. Further Discussion of Second Language Requirement

It was suggested that perhaps the Senate could canvas the departments for their thoughts on the language requirement. It was noted that if we add eight credits to Academic Foundations, departments will have to take eight credits out of the majors. It was cited that the Senate should at least inform the departments of the history of the second language requirement, including the Board of Regents credit cap, and that they can now review and change their programs since we no longer have the cap.

It was stated that if the Senate really believes we should have a second language requirement, we should take some positive action and let the departments figure out how to accommodate a language requirement. We should also have a letter to the faculty or departments ready when the Academic Foundations Committee reports in December, describing what we intend to do. It was noted that we should also investigate the language requirement at other universities, especially for BA requirements versus BS requirements.

Sheila McGinnis, Director of the Health Administration Program, stated that there are many challenges in health care today, including a healthcare system that is very vulnerable, as demonstrated by the events following hurricane Katrina. Nearly all health occupations are growing, including management of health care. The changes to the curriculum presented today are to improve our program and prepare for accreditation. The Health Administration program is interdisciplinary and includes three major components: public health and policy, business and management, and health systems and sciences. The current program mostly focuses on public health and policy, so part of this modification is to expand the other two components. Most of the students in this program are already working, so the plan of study has been designed to aid them in getting classes where they need them. Many students want to get through in two years so the plan of study allows that, but we generally encourage them to take three years to complete the program. After these curriculum changes are approved, we plan to build a curriculum map, which will include outcomes for every part of the program. Dr. McGinnis noted that this is a cohort program with a fall starting point, but students are allowed to enter the program at different points in consultation with an advisor. The question was raised as to how these new courses will be staffed. Dr. McGinnis stated that through this revision the program ended up with one more credit which will have to be taught by existing faculty, but all other courses will be covered by the existing faculty who are mostly part-time. Also, the accreditation is an evaluative process with feedback going both ways in the process.

Mike Diede, Director of the Athletic Training Program, stated that this program is undergoing a curriculum and accreditation review, and the accreditation agency is quite prescriptive. Currently in the program there are three-credit courses that include three components: lecture, hands-on lab time, and field experience. The new courses above basically move the field experience into a separate course so it is clearly defined for students where the field experience credits are. This change will give more credit for the same experience. There will be no new faculty needed to teach these courses. They will be covered by Dr. Diede and existing part-time faculty.

Kyle Colling, Department of Rehabilitation and Human Services, stated that the first change is to alter the structure of the AA to conform to the guidelines for licensure as a chemical dependency counselor in Montana, and also ensure a smooth articulation into the BS program. Most of the courses in the AA are upper division so we don't have to get additional staff to teach separate courses for the AA students. The capstone is required by the guidelines and will be taught in load by one of the current faculty. Item 13 will change the title of our BS degree due to a change in rehabilitation counseling. In the old days, you could become a rehab counselor with a four-year degree, but now they require a master's degree. Our bachelor's students now mostly get jobs in mental health area so the degree in mental health will make their degree more marketable.
