Provost Mark Pagano stated that he would report on COMPASS in two weeks.

Dr. Pagano noted that the Executive Budget Council has been working fast and furious on the budget recommendations and have come to some draft conclusions. They will report out to the UBC on January 20, and he will share this information with Senate as well at the next meeting.

The Senate congratulated Dr. Pagano on his selection as the next Chancellor for the University of Washington Tacoma. His last day at MSUB will be March 16, and the search for a new Provost is set to begin immediately.

The question was then raised as to why the Senate asks about budgeting and staffing concerns when those are the concern of the administration. It was noted that it is important to get faculty thinking about staffing and being aware of the larger picture when proposing curriculum.
