Those MUS principles are fairly vague, so working with the eLearning Fellows, they have developed a set of principles that give a basic sense of what an online course should be. These are not meant for faculty evaluation purposes, but faculty being evaluated may use them if they wish. Once this is up and running, it will be out on the webpage with links to information and resources. The eLearning office is also working toward a part-time faculty orientation for online courses.
