Susan Gilbertz called the meeting to order at 3:41 p.m. in the Chancellor's Conference Room.

The minutes of December 10 were accepted as presented.

I. CHANCELLOR REPORT

Chancellor Nook stated that our enrollment for Spring is doing OK. It's not great, but it's pretty OK. For total FTE, they had budgeted for about 3,150 and we are currently at 3,252.

Dr. Nook noted that we have heard from the Commissioner's Office (OCHE) that we will receive all of our performance based funding. That amount is about \$740,000 and we

have to spend it by June 30, 2016. In preparation for this possibility, the UBC did put together a list of things we could use this money for, should we receive it, so those items will now be discussed. Dr. Gilbertz noted that this will be a new reality for us: every year they will hold aside funding and see how we do based on the performance measures. OCHE discovered that many of our "lost" students were still within the University System, so OCHE doesn't consider them lost. Regarding the funding, it can be used for curriculum development and enhancements, just not over time since it must be spent this year. One strategy suggested is shadow possibilities in a syllabus, and if funding comes through at this time of the year, those possibilities can become projects in the classroom.

Dr. Nook cited that we can put some of this funding into scholarships, and in that way hold it over to the following year. OCHE also wants us to work on retention, so some funding will go to that aim. The Chancellor stated that in the future, we can probably build part of the performance based funding into our budget and treat it as "one time only" funding.

Chancellor Nook also noted that a request was made to add the Montana Center's award for assisting disabled students to the Faculty Excellence dinner, which brought about the problem that we have no process to decide which awards MSUB will award. We have processes to pick the winners of those awards, but not to weigh the importance of the awards themselves. Do we have too many? Too few? We need a group that reviews the awards from time to time. The Senate will discuss a subcommittee at a future meeting.

Dr. Nook also made the following announcements:

- Budget Updates will be on February 16 at 2:15 p.m. on the east campus and 3:45 p.m. at City College.
- The Governor made a visit to City College today and the faculty and staff did a wonderful job.
- Foundation Executive Director Chuck Wendt retired in December. The Foundation Board Chair and Vice Chair are working toward opening the position in February.

II. PROVOST REPORT

Provost Hoar noted that in regards to our Spring enrollment, Cheri Johannes, Registrar, discovered that almost all students who had not yet registered for Spring but were expected to, all had holds on their accounts. The Deans Council will be looking at those holds, because we don't want to hold a student's ability to register if it's inappropriate. There are other types of holds, such as graduation holds, that can be used.

IV. ITEMS FOR INFORMATION

Item 29 Master of Public Administration. Placing program on moratorium. For information only.

Dr. Hoar noted that with a moratorium, we retain the authority to offer the program but do not enroll students.

It was noted that another emeritus nomination that has come forward. Joy Honea, Chair of Social Sciences and Cultural Studies, apologized for not having the nomination of Jeffery Sanders in earlier. Dr. Sanders will be retiring this summer, and the Department would like to add his emeritus award to the Commencement ceremonies.

Chancellor Nook noted that under the current emeritus policy, the faculty member being nominated does not have to be currently employed. The nominations can take place after the person has retired. There are also options beyond Commencement for presenting the award, such as a private ceremony, a ceremony as part of our Fall convocations, or even at the Faculty Excellence dinner.

V. ITEM – FIRST READING

Item 35 Academic Senate Bylaws Article III. Organization of the Academic Senate Section A. Officers. Changes to Chair Elect procedures to resolve issues with term expirations and term limits. *Requires general faculty vote*.

VI. DISCUSSION/ACTION ITEMS

A. Determine Process to Delete a Course with No Academic Home

Dr. Gilbertz noted there is no report yet, but Vice Chancellor for Student Affairs Joe Oravecz is looking into the issue.

B. Prior Learning Assessment (PLA) University-Wide Protocols

We are going to have to deal with PLA, and we are going to need a campus group to do so. The system-wide effort set a basic framework, but we need to form academic policies and procedures for MSUB. Dr. Johannes noted that some procedures are already in place since Admissions & Records has been handling these for many years. We are, in fact, ahead of many other units in the system in that regard. It was noted that we may need a standing committee of the Senate to handle these, to develop policy, and to create a faculty review system. It was agreed that the Senate Executive Committee will hold a meeting to discuss how a PLA Senate standing committee should be structured and charged. It was further noted that the committee should include someone very familiar with NWCCU requirements as well as faculty from areas that will likely see a lot of PLA.

C. High-Impact Classroom Projects beyond Equipment Fee Requests

This year when the equipment fee requests went out from the Provost, there was also a call for proposals that would not come from equipment fees. Now, with this performance based funding coming through, faculty need to be thinking about non-equipment related classroom enhancements. That funding can even be used to compensate faculty while they rethink their courses to change them in powerful ways. We need to spread the word among colleagues that there is funding available and get people thinking about new ways to teach. When a new idea proves to be a good one, we need to find ways to spread it around! We need to develop a culture on our campus of enlivening programs and courses. Provost Hoar noted that we can grow by retaining more of our students, and exciting courses are a major part of that.
