I. ITEMS – FIRST READING

Item 33 PHSX 220 Physics I. Remove prerequisite and add corequisite.

- Motion by Russ Lord, seconded by Jennifer Scroggins to **approve Item 33 on first reading.**

Stan Wiatr, Chair of Biological & Physical Sciences, noted that this change is to move M 171 Calculus I from a prerequisite to a corequisite, because it's appropriate that students take the two courses together. The question was raised as to whether this will exclude students who take M 171 first, before PHSX 220, but it was noted there are very few students who do.

Item 34 Minor in Biology. Modification to an existing program.

Dr. Wiatr noted that a choice of ecology courses is being added to the Minor in Biology, one in Fall and one in Spring. In the Earth Science Minor, GPHY 282 Mapping Techniques is being added and the list of restricted electives was removed, which gives the program more flexibility. The question was raised that if students can take any upper division ERTH or GEO courses, will prerequisites be met? Dr. Wiatr responded that most, but not all, of the prerequisites would be met through the core courses of the minor.

- A.J. Otjen, Business Administration Department, stated that the course deletions are to clean up courses that are no longer offered. The program changes are to reflect how the BSBA options offered by the COB are working together, such as adding computer systems courses to the marketing option.

Trevor Brown, Welding Program, stated that this course has always been offered at 3 credits, so doing away with the variable credit makes sense. They are also removing the reference to certification in the course description, since City College cannot actually offer a certification.
