Rich Pierce, Chair, called the meeting to order at 4:00 p.m. in the Chancellor's Conference Room.

The November 19 meeting minutes were accepted as presented.

Patty Nichols, Rehabilitation and Human Services, stated that this program currently has five areas of emphasis, from which students choose one. The areas are confusing and don't work well in DegreeWorks, so those are being cleaned up and reduced to three. Several courses that are no longer offered have been removed. The core requirements of the program have been updated as well. Total credits will not change.

Paul Pope, Social Sciences and Cultural Studies, stated that when the Master of Public Administration was created in 2004, the department only offered a Minor in Political Science. So, a major was put together, and it was really just a list of courses thrown together. These changes will reorganize the program and update courses. Several courses are being updated to use Bozeman's title and/or description, since they are better than ours. The new course PSCI 458 Urban and Regional Planning is being added to stack with a graduate level course of the same name, and is unique across the state. They are also adding WRIT 201 as a requirement to the program. Students in this program have had difficulty with getting enough upper division credits, so these program changes will help. All course proposals have been checked against the CCN database.

Joy Honea, Chair of Social Sciences and Cultural Studies, noted they are experiencing a bottleneck of students in the Criminal Justice and Sociology programs. There are a few courses that all the students must take, but the Department does not have enough faculty to offer enough sections for the students. Part of the solution is to change the prerequisite for all upper division courses from SOCI 101 Introduction to Sociology to SOCI 101 or SOCI 201 Social Problems. The other part of the solution, which is admittedly more of a temporary fix, is to offer more courses less often. The faculty will teach a rotation of courses so at least one course that applies to each requirement in the majors will be offered every semester. Each individual course may only be offered every other year.

WRIT 201 will be required for all the majors, and Dr. Honea has consulted with the English Department in order to offer a section of WRIT 201 for social sciences. WRIT 201 will also be required before all upper division courses.

Dean Christine Shearer-Cremean stated that she has concerns with this temporary fix to the program. It is not a solution that will grow enrollment. Dr. Honea noted that the Department has worked hard to find creative solutions to the student bottleneck problem in light of the current budget deficit.
