Susan Gilbertz, Environmental Studies program, noted that neither of these courses have been taught in 10 years. GPHY 222 is required in the Teaching Minor in Economics, but the College of Business has started paperwork to delete that program.

Item 32.a ACTG 438 Forensic Accounting. New course.

The College of Business has been teaching this course for three summers, and enrollment has been good. Accounting students need an additional 30 credits beyond their 120-credit bachelor's in order to sit for the CPA exam, so this course will help fulfill that need.

Item 37 BSBA Online General Business Option. Modification to an existing program.

This change adds a choice of two courses that are already being substituted due to scheduling issues. The General Business option also has a need for more upper division courses.

Josh Hill, College of Business, noted that this change removes a course choice that had been added due to scheduling. They now have the staffing to offer more appropriate finance courses.

The Health & Human Performance programs have very few lower level KIN courses, so the new course is being created to fulfill some prerequisite needs and added to both programs.

The GPA requirement, which is listed in the program application but not the catalog, has also been added.

It was noted that students should have a choice between BIOB 121 Fundamentals of Biology for Allied Health and BIOB 101 Discover Biology. This change was made in Item 31.a.

III. DISCUSSION

Our concern regarding double counting of major courses in a minor was brought to the Academic Senate Executive Committee, who agreed they are not concerned with this program overlap. It was noted that this may lead to creation of lots of little programs—a slippery slope. The MUS performance based funding creates the same issue, with "completers" being such an important measure.
