Item 36.c CSCI 114 Programming with C#. Change prerequisite.

Item 36.d CSCI 121 Programming with Java II. Change credits from 4 to 3.

Item 36.e CSCI 223 Software Development. Add prerequisite.

Item 36.f CSCI 240 Databases and SQL. Remove prerequisites.

John Pannell, Computer Systems Technology, noted that this program has suffered due to a revolving door of instructors. He is adding an introductory course and balancing the program between programming and web work. The program is reduced by one credit.

There was some confusion about the capstone course (CSCI 299). It was noted that the rationale is not particularly clear since no course rubrics/numbers are included, just titles.

Second reading will be held when the issues of the capstone and the rationale can be cleared up.

**Item 33.L** BS Health and Human Performance/MS Athletic Training 3+2 Option. Modification to an existing program.

- Motion by Joseph Bryan, seconded by Jennifer Scroggins to approve Item 33.L on first reading.

It was noted that this proposal adds a physics course to the undergraduate part of the program. However, there is no explanation or rationale attached.

Item 35 HADM 498 Internship/Cooperative Educ. Change prerequisite. Item 35.a BS Major in Health Administration. Modification to an existing program.

It was noted that the admissions process for the Health Administration program was meaningless since all students were allowed in. Also, the background check is not part of program admission, but rather the internship, so it's being attached to that course. These changes add the background check requirement to the internship course and a statement regarding such to the program, while removing the admissions requirements.

It was stated that these changes delete some courses that have not been taught and create a new, general course in botany. The general botany course needs to be a prerequisite for the upper level courses; thus the prerequisite changes. Also, the new BIOO 320 & 321 are included in the updated Environmental Studies program, which the Committee has already seen.
