II. APPROVAL OF MINUTES

III. ITEMS – FIRST READING

Item 10 EDU 330 Emergent Literacy. Change prerequisites.
Item 10.a EDU 430 Teaching Reading K-3. Change prerequisites.
Item 10.b EDU 432 Lit & Literacy for Young Adlts. Remove prerequisites.
Item 10.c EDU 435 Theories in Reading. Remove prerequisites.

Rachael Waller, Educational Theory & Practice, noted that EDU 433 is a barrier for students as a prerequisite for these courses, so it's being removed. It was noted that EDU 432 and 435 (Items 10.b & 10.c) both have a prerequisite of "Admission to Educator Preparation Program," which should remain. The forms will be edited to include this prerequisite.

It was noted that communication on this program last spring during Strategic Program Alignment became unclear. In the paperwork which came to Senate, the Pharmacy Tech program was placed on moratorium, but the program was actually deleted at the BOR level, because there are no students in it. This paperwork just cleans up what has already been removed, and also gets rid of the courses.
