John Roberts, Music, stated that commercial music is the fastest growing degree in music in the U.S. right now. Our current programs are classically focused, but the Commercial Music program will focus on production, composition, performance, and arranging in a variety of styles. Music used the University of Miami, USC, and UCLA as examples on building the curriculum.

A question was raised about the outcomes of the MUST courses. Mr. Roberts noted that the outcomes have been updated so they will be different from the 294/494 outcomes, and all majors will take at least one of those courses.

It was cited that the MUSI 190 Forum course is 0 credits, which we have not really done at MSUB before. Mr. Roberts noted the course is pass/no pass and is intended to make the requirement that students attend music performances part of the curriculum. Students have been encouraged to attend performances, but the faculty needed a way to make sure it happened. Most music programs across the country have a similar, no credit requirement.

A few questions were raised about technical issues with CourseLeaf. The MUST 294 and 494 courses may disappear from the catalog and have to be replaced. The subtotals in the Art proposal above were not functioning correctly, which has been reported to CourseLeaf.
