Department Updates (Reprinted as Submitted)

Suzette Nynas, Chair of Academic Senate

In addition to curricular changes we are continuing work on an AI policy. Two Academic Senate Bylaw modifications (electronic voting and term limits) were approved by Senate and have been sent to full faculty vote. Academic Senate Executive Committee meet and approved the plan of study template but need to determine where these will be house and how we will ensure updates will be made as curriculum changes. We are working to discover more information about a course rotation template. Today in Senate, (11/14) we will be finalizing the administrator evaluations and discussing the Emeritus faculty nomination process as well as the rights, responsibilities and privileges of emeritus faculty. The College Experience Course is making its way through the Curricular process, and I hope to have an update by early December to share with the Cabinet.

Shiloh Skillen-Robison, Interim Director of University Communications and Marketing

Two finalists visited campus for the Director of UCAM position recently. The committee met on Friday to discuss and will be supplying the Chancellor with strengths and weaknesses for each based on campus feedback.

UCAM and Admissions are working through updating communications materials to potential students and will begin looking at comm flows to align messaging across all channels (social media, printed materials, e-mail communications, etc.)

The Budget team is working on mid-year projections for FY25.

Institutional accreditation update: Mark you calendars! The NWCCU Year 7 comprehensive visit will take place October 8-10, 2025. The corresponding EIE report will be due to the NWCCU on August 1, 2025. A draft of the EIE report is in the works. Please be timely when responding to requests related to our upcoming accreditation work. Curricular and co-curricular program assessment will be a focus of the year 7 visit, along with our use of Student Achievement data for decision-making (where appropriate). We are awaiting final feedback from the NWCCU for the Year 6 PRFR report. This feedback will likely come in November/December.

Program-level accreditation update: The Nursing program at City College hosted a re-accreditation visit in October. While we await official findings, we feel confident the review was successful. Thank you to everyone who participated and supported our Nursing program during their review! The College of Education will have their virtual re-accreditation visit April 9-11, 2025 with CAEP, which will also include a state accreditation review. If you are asked to participate in a meeting with the review team, please be sure to attend the meeting, prepared to discuss your work with the College of Education faculty and/or students.
