For spring 2025, 221 enrolled students were participants in the MT10 program: 81 at City College and 140 at University Campus. 12 of these students intended to graduate this spring (11 AAS and 1 BS) and 2 students intend to graduate in summer (1 AAS and 1 BS).

INFORMATION

Commencement Debrief

Natalie Preston, Executive Assistant to the Chancellor, reported on the commencement debriefing meeting that was held on May 5, 2025. During the meeting, feedback was shared on Saturday's commencement ceremony which was mostly very positive. Dan Carter, Director of University Communications and Marketing reported that approximately 700 students received degrees, and the livestream of the event was accessed by more than 1,100 people. Federal Update

Dan Carter provided an update of state and federal legislation impacting the university system. Chancellor Hicswa confirmed that an AmeriCorps VISTA position at MSU Billings has been eliminated. Funding for TRIO and Upward Bound are currently not in the President's proposed budget. Dan Carter explained that Congress is responsible for appropriating funding, which may or may not align with the administration's priorities. The Corporation for Public Broadcasting was ordered to reduce spending that impacts 8% of the Yellowstone Public Radio annual budget.

The Montana Legislature ended its session on April 30. The University System will receive additional appropriations for the state employee pay plan, 1-2 Free, and the Montana 10 program. Chancellor Hicswa credited the Commissioner's Office (OCHE) for working closely on budget requests with the Governor's Office.

Strategic Plan Planning

Kathleen Thatcher, Director of Assessment and Accreditation, reviewed the previous process that produced the current Mission, Vision, and Values, and Strategic Plan. As the university reaches the end of the current strategic plan cycle, Chancellor Hicswa charged Kathleen with assembling a committee to steer the next iteration of our strategic plan.

The committee, which Kathleen is working to finalize, will encourage participation of faculty and staff members in strategic visioning sessions facilitated by Karen Miller of Kaleidoscope Group. The goal is to identify 3-5 broad themes during the strategic visioning process. Facilitated sessions will be held following the NWCCU Year 7 visit, which is scheduled for October 8-10.

MSU Bozeman Employees on Campus

Leslie Weldon, Vice Chancellor for Administration and Finance, announced that previously remote MSU Bozeman employees will begin using office spaces on the university campus and City College starting July 1.

Intermountain Health Parking

Leslie Weldon announced that her office has finalized a lease agreement with Intermountain Health for the use of parking spaces on our campus. Intermountain Health employees will be able to rent spaces in part of the Virginia Lane lot, certain areas of the parking garage, parts of the northeast Poly Drive lot, and the lot adjacent to Apsaruke Hall. The lease went into effect on April 28.

Facilities Summer Projects

Leslie Weldon announced that there are many summer facilities projects underway. Projects include: phase two of the water main project, housing updates, replacement of the Physical Education Building roof, and Information Technology (IT) networking projects throughout campus. Justin Rife, Director of Facilities Services, will continue to email facilities project updates on a regular basis.

Sodexo Update

Leslie Weldon updated the group on the Request for Proposal (RFP) issued for provision of campus dining services. Sodexo submitted an RFP and Leslie's office is reviewing it. Dining services and facilities on City College campus must be considered in the proposal. Jazzman's Coffee and the Sub Connection will remain closed.

Provost Transition

Chancellor Hicswa reported that she recently met with incoming Provost Lee Vartanian. Provost Vartanian will begin in his role on July 1. Natalie Preston is collecting items for a gift basket for Dr. Vartanian if anyone would like to contribute.

Evaluations

Chancellor Hicswa reminded Cabinet members of the importance of completing a performance review for each employee every year. Kathleen Thatcher confirmed that the Northwest Commission on Colleges and Universities (NWCCU) considers regular employee evaluations to be important. Paula Highlander, Director of Human Resources, explained that while the review process is a good time to set expectations and goals for the upcoming year, they do not need to be completed before the fiscal year ends on June 30. Paula also recommended updating position descriptions in conjunction with evaluation completion. Human Resources can provide additional copies of evaluation forms if anyone needs them.

Chancellor Hicswa reminded Cabinet members to use vacation time and encourage employees to use vacation time.
