SHOUT-OUTS

Fall Enrollment Update

Vice Chancellor Hayworth gave an overview of enrollment, which is tracking up, even with dual credit students excluded from the numbers. She explained that the drop for non-payment period has not yet ended. Dr. Hayworth also reported that the retention rate for the freshmen cohort is currently tracking higher than last year's rate. Overall, the retention rate has only increased incrementally.

NWCCU Visit

The NWCCU Evaluation of Institutional Effectiveness (EIE) Year 7 Visit is scheduled for October 8-10, 2025. Kathleen Thatcher confirmed the specific meetings on the visit agenda that Cabinet members should be sure to attend. She asked the group to review the EIE Report, with emphasis on sections 1.A.1, 1.B.1, 1.B.2, 1.B.3, and 1.B.4 and to click on any links to see evidence of strategic planning accomplishments. Kathleen reminded Cabinet members to be familiar with the university mission statement, and to be prepared to speak about how the operational plan intersects with the strategic plan.

Strategic Plan

Kathleen Thatcher reported that the strategic planning steering committee met with Kaleidoscope Group on Friday, September 12. The survey that was distributed campus-wide in August closes on September 19. Another survey will be distributed via Admin General in November. Please respond to this survey as well.
