Graduates earning the Bachelor of Science in Biology degree with the Medical Lab Science (MLS) option at MSUB are immediately eligible to become nationally certified. Certification is accomplished by passing

the American Society for Clinical Pathology (ASCP) Board of Certification Medical Laboratory Scientist Exam. See additional information for ASCP Certification here. The profession of Medical Laboratory Scientist does not require a license in certain states. However, certain states do require a license to practice in this field. Requirements for licensure vary from state to state. The ASCP Board of Certification
