Bob Carr stated that this is a new program with a new faculty member. The program of study emphasizes planning for and prevention of emergencies, rather than reaction to emergencies.

The Senate then stopped to thank Bob Carr for his many years of excellent service to MSU-Billings. The Senators enjoyed working with Mr. Carr, and wish him well.

II. OLD BUSINESS

A. Further Crippen Cabin Discussion. Michael Dennis, Associate Professor of Biology, explained further the intent of his memo which was distributed at last week's Senate meeting. He stated that the University could remove the cabin, making it a

reclamation project for Environmental Studies students. This would make the University look much better. It was noted that this solution would be the only "right" educational use of the cabin. It was also noted that deconstruction of the cabin would not be terribly expensive.

It was cited however, that sending students or faculty into such a structure puts them at risk of contracting the Hanta virus (carried through mice). It was suggested that the University contract out the clean-up of the inside of the cabin. Then the Forest Service could burn it or otherwise remove it, and MSU-Billings could work with the Forest Service in a reclamation project. It was also noted that according to the materials the Senate has, MSU-Billings owns everything in the cabin. These items would have to be removed (including a huge wood stove) by either the University or a contracted professional company.

Sandie Rietz announced that a book of materials from the Montana Wilderness Association will be in the Senate Office (McM 214) for the next week. All Senators are urged to come to the Senate office and review the marked materials. Some of this material will go into the book of items on reserve in the Library.

The two main complaints the Senate has were then reiterated. First, the Senate is irritated by the violation of the spirit of the Wilderness Act of 1964. Second, the Senate believes the faculty was misrepresented in "volunteering" educational opportunities for the cabin.

III. NEW BUSINESS

A. Recommendations from the General Education Committee. The General Education Committee has no report yet, but will be meeting again on April 24, after which the Committee should have materials to present to the Senate.

George Madden then announced that Hugh Curtler, author of *Recalling Education*, will be on campus Thursday, May 9, 2002 for a radio broadcast discussion. Dr. Madden would like Mr. Curtler to meet with the Gen Ed Committee, and also have the committee members attend the broadcast (in Cisel Recital Hall) where the audience will have a chance to ask questions.

B. BOR Policies on Information Technology and Computers. Randall Gloege stated that he is calling a meeting of the Academic Computing and Allied Technology Committee to discuss the BOR Policies. He will bring a report to the Senate next week.

C. May 23-24 Board of Regents meeting in Dillon. It was noted that Ron Sexton has been told to be very prepared to discuss the Crippen Cabin.

The meeting adjourned at 5:08 p.m.
