The Environmental Studies program is also working up an agreement for a 2+2 with Miles Community College so their agriculture, range management, and wildlife students can come to MSUB and complete the BA in Environmental Studies.

VI. DISCUSSION/ACTION ITEMS

A. NSSE Data

This data includes survey results from freshmen and senior students, as well as faculty. Provost Arnold noted that sharing this data is part of a larger initiative to share data across constituencies.

We have struggles surrounding advising and an Advising Task Force is being created to review how we advise and how to improve both professional advising and faculty advising. The Gen Ed concerns were shared with the Gen Ed Committee.

It was noted that having the data disaggregated by college would be helpful. It was also noted that we had indicators set based on 2016 NSSE data, but nothing was done in response to those. It was cited that City College students are included in the freshmen survey but not the senior survey, because NSSE is set up for four-year programs only.

The Senate agreed that a discussion of the data will wait until the "snapshot" of summarized information is available, which may be a long time.

VII. NEW BUSINESS

With the reorganization of the Colleges of Arts & Sciences and Allied Health Professions pending, the Senate should consider revising how the colleges are represented. Currently, we have one representative from each college and eight at-large representatives. Perhaps we could have two representatives from each college and three at-large representatives. It was noted that changing the make-up of the Senate will require a general faculty vote.
