# A. Learning Outcomes: Kathleen Thatcher, Director, Assessment & Accreditation and Jen Lynn, Chair, Academic Senate

Dr. Lynn could not be present today. Ms. Thatcher presented on the importance of quality learning outcomes, for both courses and programs. All committees in the curriculum process need to be giving feedback to faculty on the quality of their outcomes. The GEC has already done great work writing the Gen Ed Program Outcomes.

## V. DISCUSSION/ACTION ITEMS

## A. Artifact Collection Summary and Discussion

Several members discovered that the data had been collected, but not passed on and added to the Box folder. Some submitted the assignment prompt, while others submitted student work. Some used the category outcomes, while others used the new program outcomes; however, our messaging was not very clear in emphasizing use of the new program outcomes.

It was noted that Biological & Physical Sciences created a table of their submissions which could be useful for any department.

It was suggested that a repository of this information, kept open for the two years until this review happens again, would be very useful for faculty collecting artifacts. Instructors also need to know this is coming around again, but many of them are part-time.

It was further suggested that the GEC require a naming convention for all files submitted. Having an entire department's Gen Ed offerings in one folder is difficult to sort through without having them organized by file name.

Another suggestion was to use a Qualtrics survey to collect the data. Qualtrics does allow for documents to be submitted.

## B. Assessment Rubrics: Presentation by Kathleen Thatcher

Ms. Thatcher discussed:

- Identify the various levels of assessment
- Identify the intersection of course and program level assessment
- Review the assessment process for General Education
- Close the loop on assessment practices

She also discussed a number of options for an assessment rubric.
