George Madden called the meeting to order at 3:40 p.m. on Tuesday, November 12, 2002 in room B001 of the College of Technology.

It was stated that the courses and program in Item 27 are for someone who may own a small business and who needs some Human Resource training, or other such situations. Students who complete the program would not move directly to an HR manager's role, but in a lower position moving that direction. The new program of study is made up of the new courses presented today, as well as existing courses.

It was noted that the College of Business has some interest in this program. It was noted that this program could be a feeder for baccalaureate degrees from the COB. It was suggested that the COB talk with the COT about this program. It was noted that some discussion already took place, but since both colleges have new deans, that discussion may be lost to time.

It was also noted that the COT is in the skills market, whereas the COB is more a careeroriented program. Most COT students will go to work right after completing this program.

It was also noted that this program was unofficially announced some time ago, and there are already students in this program, even though the program does not yet exist. Those students are taking their gen eds, but they will need courses to take next semester. This should not happen, but since it has, we must do what is best to serve the students.

It was also noted that in a budget situation like the current one, if a new program is created, usually another program is cut. Will programs on the Senior Campus be cut to compensate for the COT's new programs?

It was noted that we need to get in the habit of communicating between the two campuses.

John Cech, Dean of the College of Technology, stated that he had not heard about moving gen eds out to the COT. However, growth at the COT benefits the entire University.
