Tim Urbaniak called the meeting to order at 4:03 p.m. on Wednesday, January 26, 2005, in the Missouri room of the SUB.

The December 1 meeting minutes were accepted as presented.

I. ITEMS – FIRST READING

Item 55 Teaching Minor in Mathematics. Modification of an existing program.

- Motion by Dixie Metheny, seconded by Bruce Brumley to **approve Item 55 on first reading.**

Dr. Metheny noted that this change to the minor is the same as the other changes that came through on the teaching majors: adding a capstone course required by OPI.

- Motion by Vern Gagnon, seconded by Mike Diede to **approve Items 57, 57.a, 57.b, 57.c, 57.d, 57.e, 57.f, 57.g, 57.h, 57.i, 57.j, 57.k, 57.L, 57.m, 57.n, 57.o, 57.p, 57.Q, and 57.r on first reading.**

Mick Ender, Director of the Radiologic Technology Program, stated that the program was developed before he was hired (to facilitate Board of Regents approval). These changes reorganize the program so it makes more sense for students. He surveyed about eight different programs around the region in building the program, but accreditation largely dictates the content of the program.

It was noted that the COT has a history of starting programs before any faculty have been hired into them. After the faculty are hired, they usually have to do a complete overhaul of the curriculum. This has to stop somewhere.

Lonnie Schrag, Team Leader of Nursing, Health, and Safety Occupations, remarked that the changes to the programs are minimal. All four of the health programs at the COT will now share a common core, including HLTH 100 which surveys all four programs so students know what they are getting into. This will increase retention, because if students change their minds they don't have to start all over again in a new program.

Item 59 AAS in Computer Systems Technology. Modification of an existing program.

Item 59.a CST 280 Integration of Microsoft Windows 2000, Novell NetWare and Unix. Change title, course description, and prerequisites.

It was cited that there have been developments in the program, and these Items need revising.

- Motion by Bruce Brumley, seconded by Susan Gregory to **return Items 59 and 59.a to the department for re-working.**
