Tom Rust of the History discipline stated that for the last few years the History faculty have barely been holding the curriculum together, as they had lost so many faculty members. They have now hired a new faculty member and are in the works to hire another this year, if the hiring freeze doesn't stop it. The changes above are to make a scattered curriculum make more sense and also take advantage of the expertise of the new faculty. Some faculty will also be retiring, and their courses they teach have to be deleted as they won't have someone to teach the courses. These changes also move several thematic History courses to the 400 level for students that are bound for graduate school. Several of the period courses are being reperiodized to make more sense and also cover some holes (as much as 400 years) that were missed in the old curriculum. Mr. Rust noted that in 2000-2001, the History discipline deleted 19 courses due to faculty losses. The above Items add 14 new courses.

It was noted that Archeology has been quietly carried out on this campus for 10 years, and these changes will bring some of that to light and perhaps attract some new majors.
