Lorrie Steerey stated that she met with Craig McKenzie and they discussed the common courses to the COT and COB in this program. The solution chosen was the COT will use some of the existing courses in the COB on visual basic. The courses will be cross-listed with two rubrics (CST and MIS) and will have both a 200 and a 300 level number. They also agreed that Mr. McKenzie will teach the Cisco lab to COB students at the COT. Dr. Steerey noted that AACSB has realized that every school is different and requires different instructors for its needs.

Mr. McKenzie stated that they propose this package be approved now, and in the fall the COT and COB will bring forward changes for the courses they discussed. It was noted that this program will not go into the 2004-2005 COT catalog.

It was noted that the scheduling of the COB courses has been worked around the COT students' schedules, so they will have time to come to the main campus for these courses.
