The meeting was called to order at 4:00 p.m. in the South Conference Room of the COT Health Science Building.

The February 2 meeting minutes were accepted as presented.

I. ITEMS – FIRST READING

Item 37 BS Health & Human Performance Human Performance Option. Modification of an existing program.

Vern Gagnon, Interim Dean of the COT, noted that this program change includes course changes that were made over a year ago. The courses were split out into separate lecture and lab courses, and the program now reflects those changes. It was cited that the Process Plant and Power Plant programs share a common first year. The Process Plant program was changed but the Power Plant was not.

Craig McKenzie, Computer Systems Technology, stated that they thought they had an understanding that some of their courses would be modified during the Common Course Numbering/FLOC process. However, that did not happen. These course and program changes fix those issues.

Item 44 M 098 Beginning & Intermediate Algebra. New course.

- Motion by Mark Jacobson, seconded by Gary Acton to **approve Item 44 on first reading.**

Chairsty Stewart, Interim Assistant Director of the Academic Support Center, stated that this course will simply be another option for students. The course is five credits and each credit is a module. Students do not progress in the course until they have passed the current module. This course is offered every Fall and Spring and initially, students register for all five credits. If they fail a module, they come back the following semester and register for just the remaining modules, not all five. Basically, the student withdraws from the remainder of the course and does not have to pay for the remaining credits until they re-take them the next semester. Students can also test out of the modules, especially if they did not do well on the COMPASS test but know the material in the first few modules.

Ms. Stewart noted that M 098 will be an option for students to take instead of taking both M 090 and M 095. This is currently the second year they have run this module course as a pilot and are now formalizing it as a regular course.

Ben Barckholtz, Director of the Academic Support Center, noted that students are succeeding in this course at a higher rate. This course gets down to what the students know to get them where they need to be and it puts more responsibility on the student. Mr. Barckholtz noted that all developmental education courses do not count toward graduation or GPA.

The question of transferability was raised. It was cited that developmental education courses don't need to transfer, but the outcomes and objectives for M098 are the same as M 090 and M 095.
