Cindy Dell called the meeting to order at 4:02 p.m. in the Chancellor's Conference Room.

The October 24 meeting minutes were accepted as presented.

I. ITEMS – FIRST READING

Item 26 PSYX 315 Development Over the Lifespan. New course.

- Motion by Brian Gurney, seconded by John Hoover to **approve Item 26 on first reading.**

Mike Havens, Chairperson of Psychology, stated that this course will primarily be for the Bozeman nursing students (not the City College nursing program). The Bozeman nursing program requires a “lifespan” psychology course, and we have always offered two courses, one in child/adolescent psychology and one in adult psychology. With the hiring of a new faculty member, we can now offer this one course instead. Dr. Havens noted that there is a Common Course Numbering issue with another unit in the system. They offer this course at the 200-level, but the MSUB course will be 300-level with a research component. Because of this issue, it's possible this course will go into the catalog with a different number.

Item 19 BS in Education Secondary Education/Special Education (P-12) Double Major. Modification to Item an existing program.

Item 19.a BS in Education Elementary Education/Special Education (P-12) Double Major. Modification to an existing program.

Item 19.b Non-Endorsable Teaching Minor in Special Education (K-12) Concentration. Modification to an existing program.

Item 19.c Teaching Endorsement in Special Education (P-12). Modification to an existing program.

- Motion by Brian Gurney, seconded by John Hoover to **approve Items 11, 11.a, 11.d, 11.e, and 19 through 19.c on first reading.**

Susan Gregory, Educational Theory and Practice Department, stated that the prerequisite changes are very simple. The credit change for SPED 420 will make it easier to place students for student teaching in School District #2, as well as bring the student hours down to a more reasonable level. SPED 260's course description is being updated as there is not a lab requirement for the course. The program changes are all reflections of course and credit changes.

- Motion by Brian Gurney, seconded by Ying Wang to **approve Items 11.b, 11.c, 13, 13.a, 13.b, and 13.d on first reading.**

Ken Miller, Chairperson of the Educational Theory and Practice Department, stated that the last time the Elementary Education major was updated was when we converted from quarters to semesters. After two years of research, the department decided to make the elementary program an extended major. They have added 15 credits, taken instead of a minor, and those credits include new courses in special education, reading, technology for learning, classroom management, and assessment. Elementary Education majors will not have a minor, and MSUB was unusual that we required a minor in the past. Staffing for these new courses has been handled, although some part-time faculty will be needed.

Dr. Miller noted that they have hired a new faculty member in math education, who has recommended we offer two math methods courses rather than just one. We currently offer math methods for grades 9-12, so this new course will cover grades 5-8. The math program changes will be coming later.

Item 15.b COMT 482 Women, Media and Health (crosslisted with COMT 582, HADM 482, HADM 582, HHP 482, and HHP 582). Change rubric to COMX, change title to Women, Media and Society, and change course description.

- Motion by Brian Gurney, seconded by John Hoover to **approve item 15.b on first reading.**

It was noted that an email was received confirming that the course will remain crosslisted with all mentioned rubrics.
