Rich Pierce, Chair, called the meeting to order at 4:01 p.m. in the Chancellor's Conference Room.

The November 5 meeting minutes were accepted as presented.

I. ITEMS – FIRST READING

Item 57 CSTN 136 Rigging and Metal Buildings. Delete course.

Item 57.a CSTN 201 Advanced Concrete Working. Delete course.

Item 57.d AAS in Construction Technology-Carpentry. Modification to an existing program.

- Motion by Brian Gurney, seconded by Ying Wang to **approve Items 57 through 57.d on first reading.**

Tim Starns, Construction Program, stated that CSTN 136 Rigging and Metal Buildings doesn't really fit into the Construction Technology-Carpentry program, as it's not something carpenters do. The new course CSTN 272 is being added because estimators are in high demand. Terry Madtson, Construction Program, stated that CSTN 201 Advanced Concrete Working is being removed from the program because the students get enough knowledge in concrete with the first year of the program they can actually enter as a concrete apprentice, so the advanced course is not needed. Mr. Madtson also noted that, at the end of the program, all the students make presentations to demonstrate their project management skills.

Francisco Saldivar, Sustainable Energy program, stated that these changes come along with another SWAMMEI grant certificate, which will produce electrician helpers. Two new courses need to be added, and the students will receive NCCER credentials from the courses. The name of the Certificate of Applied Science in Sustainable Energy Technician is being changed to reflect the electrician focus. The courses removed from the Certificate of Applied Science in Sustainable Energy Technician, now the Certificate of Applied Science in Energy Technician, will not be deleted, since the Certificate of Technical Skills in Energy Technician program may not continue after the grant ends.

It was noted that the Certificate of Technical Skills in Energy Technician should be a Certificate of Technical Studies instead. This will be changed on the form to match the certificate titles published by the Commissioner of Higher Education Office.

Clinton Culp, Outdoor Adventure Leadership program, stated that they have folded together and thus deleted several courses that had overlapping outcomes. They are also updating many course descriptions to match terminology used by the accrediting body, the Outdoor Education Association. Some prerequisites are being added to ensure proper course progression, as well. A basic course in business and another in marketing have also been added, in consultation with the College of Business. Those credits come from the six freed credits from Gen Ed. In terms of the budget, they have cut one part-time instructor, and the courses will be taught on an every-other-semester or every-other-year rotation by Dr. Culp and Lynn Fitzgerald.

Russ Lord, Health & Human Performance, noted that these changes are to keep the program up to date and fix some problems due to Common Course Numbering. Several elective courses that are no longer offered by other departments have also been removed. There is no change in total credits.

This course will be taught by Matt McMullen of the Psychology Department, and he will not be paid, so it is free for the Department of Health & Human Performance. The students will play at the Eagles Lodge, which has agreed to donate time for the students to play.

It was noted that the form states the course is one credit with one hour of lab per week. This is not correct, and will be fixed before second reading is held.

This Item will be postponed to the next meeting, at the request of the faculty member who ended up serving jury duty today.

Item 24 BSEd major in Broadfield Elementary Education. Modification to an existing program.

Item 25 EDU 397M Methods K-8: Integrating the Arts into the Curriculum. New course.

Ken Miller, Chair of Educational Theory and Practice, stated that they are adding a merged introductory course for education for both elementary and secondary, rather than having two separate courses. HTH 101 was added to the program in error through Common Course Numbering, so the correct course, HTH 201 Health Issues for Educators, is being added. The six free credits from Gen Ed will remain restricted electives.

Rachael Waller, Educational Theory and Practice, stated that they are removing EDEC 310 Child in the Family from both of these programs, in favor of adding the new Junior Field course. This change decreases both programs by one credit.

Cindy Dell, Educational Theory and Practice, stated that these changes are a cascade effect from the earlier noted merged introductory course for education for both elementary and secondary. These changes also clean up some incorrect wording and credit numbers in the programs.

Dr. Waller noted that the prerequisite is preventing reading majors from registering for this course, so it is being removed.

Brian Gurney, Business Administration, noted that they are clarifying their capstone course. There is currently more than one rubric for the capstone, but all taught by the same instructor. To simplify, all students will now take BGEN 499 Capstone. The City College course CAPP 131 Basic MS Office is also being added to the Business Core. The changes to the Online General Business program are mainly clean up.
