Rich Pierce, Chair, called the meeting to order at 4:00 p.m. in the Chancellor's Conference Room.

The January 21 meeting minutes were accepted as presented.

I. ITEMS – FIRST READING

Item 78.f AA in Education. Modification to an existing program.

Item 78.g Minor in Early Childhood Studies. Modification to an existing program, including title change.

Item 78.a EDEC 381 Early Childhood Curriculum and Methods. Change credits from 3 to 2.

Item 78.c EDEC 352 Math and Science in Early Childhood. New course (offered only online).

Item 78.d EDEC 385 Integrated Curriculum in Early Childhood Education. New course.

Item 78.e EDEC 495 Early Childhood Student Teaching. New course.

- Motion by Russ Lord, seconded by Brian Gurney to **approve Items 78.a through 78.e on second reading.**

It was noted that Item 78.d, EDEC 385, has been changed from 2 credits to 3. They have folded in the practicum course and raised the credits. The question was raised at the last meeting regarding EDEC 352 being 5 credits in the CCN database. Western has always offered the course at 3 credits, so the 5 is an error. Therefore, the MSUB course will also be 3 credits.
