Carl Castles called the meeting to order at 4:00 p.m. in the Chancellor's Conference Room.

The minutes of November 29 were accepted as presented.

I. ITEMS – FIRST READING

Item 33 BA Major in English. Modification to an existing program

Item 33.a BA Major in English Teaching Licensure Option. Modification to an existing program.

Item 33.b LIT 230 World Literature Survey. Change title to World Literature and change course description.

Item 33.c LIT 460 Studies in British Literature. Delete course.

Item 33.d LIT 461 Studies in American Literature. Delete course.

Item 33.e LIT 464 Studies in Medieval Literature. Delete course.

Item 33.f WRIT 339 Teaching Writing and Literature. New course.

- Motion by Brian Gurney, seconded by Joseph Bryan to **approve Items 33 through 33.f on first reading.**

Tom Nurmi, English, Philosophy & Modern Languages, noted that these changes streamline the English programs and add some program assessment through the capstone course. The three courses being deleted are not regularly taught, but the Department can always do a seminar if the interest and need are there. The new course (Item 33.f) is based on the 300-level course at Bozeman. There are no changes in total credits and no additional staffing is needed.

Item 44.d KIN 364 Research Methods in Health and Human Performance. Add prerequisite.

It was stated that students will need to be admitted to the Educator Preparation Program before taking HEE 309. It was noted that students double majoring in Elementary/Reading or Elementary/Special Ed may have difficulty getting this course into their plans of study.

For the KIN courses, KIN 105 Foundations of Exercise Science is being added as a prerequisite.

Rachael Waller, Educational Theory & Practice, noted that the program change is switching out one course for another, which they have been doing as a substitution anyway. The course being added has more contact time with children, which also allows for more service to the community, since the program is in high demand.
