Carl Castles, Chair, called the meeting to order at 4:00 p.m. in the Chancellor's Conference Room.

The minutes of September 26 were accepted as presented.

Dr. Boerboom stated that this program will be run through Extended Campus. Students will take three 1-credit introductory courses, which prepare them for the three 3-credit upper division courses. All of the upper division courses have a prerequisite, so those prerequisites would need to be waived for these Certificate students. The Extended Campus courses will be taught out of load, so there will be no additional staffing needed. These 1-credit courses will be online but with a single class meeting on campus, probably on a Saturday. This program is intended for professional adult learners, and our regular students would likely not find the certificate program useful.

A question was raised as to how the students taking the Certificate program through Extended Campus would be added to the upper division courses. Will they be in the same section? Extended Campus students pay for their courses differently. The Senate may wish to discuss this topic further.

Vern Gagnon, Chair of Business, Construction & Energy Technology, noted that the faculty member who originally proposed these changes last Spring has since left City College. They are already on a teach-out for one program, the Certificate of Technical Studies in Energy Technician. This program was designed under a grant to be a stackable credential, but there was very little interest in the program, and it does not serve an industry need. It mainly served as an exit point in the program.

The AAS in Sustainable Energy Technician has struggled with enrollment, and with fewer classes offered, it became difficult for students to finish in two years. The proposed changes will alter the focus of the AAS to Instrument & Electrical Technician, which has a lot of crossover with the previous Sustainable Energy program. The solar and wind courses are not needed, but much of electrical content can be retained. The solar and wind energy courses have not yet been deleted, and they may be able to offer them in some capacity through Extended Campus. The new Instrument & Electrical Technician program will not require any new courses and the changes will actually reduce the staffing by one half-time position.

The Certificate of AS in Energy Technician program will be less narrowly focused than the AAS, and can be useful to someone who wants to work as an electrical contractor or to begin an electrician apprenticeship. Agreements on apprenticeships will still need to be hammered out with the electrician's union.
